

# Membership fees for ordinary members

**amfori annual membership fees for ordinary members are based on a company's total consolidated annual turnover for the latest fiscal year. Companies with an annual turnover below €500,000 cannot join amfori.**

amfori offers the following standard membership options. Fees are shown in the tables below.

## Option 1: Full amfori Membership

The following amfori membership fees apply to companies interested in engaging in amfori's full services, amfori BSCI, amfori BEPI and Advocacy

Annual Turnover	Annual Fee
≤ 20 Million €	3.000 €
> 20 Million € ≤ 100 Million €	6.000 €
> 100 Million € ≤ 500 Million €	12.000 €
> 500 Million € ≤ 1 Billion €	18.000 €
> 1 ≤ 5 Billion €	24.000 €
> 5 Billion €	30.000 €

## Option 2\*: amfori BEPI (only)

The following amfori membership fees\* apply (for a limited time period) for companies interested in engaging in amfori BEPI only

\*Option 2 fees are valid from 01/01/2017 to 31/12/2019.  
From 01/01/2020, the fees will double.  
From 01/01/2021, full membership fees will apply.

> 20 Million € ≤ 100 Million €	2.000 €
> 100 Million € ≤ 500 Million €	4.000 €
> 500 Million € ≤ 1 Billion €	6.000 €

> 5 Billion €	10.000 €

### Option 3: Advocacy (only)

The following amfori membership fees apply to companies and organisations interested in trade and sustainability advocacy and stakeholder engagement only

Annual Turnover	Annual Fee
≤ 100 Million €	2.365 €
> 100 Million € ≤ 500 Million €	3.575 €
> 500 Million € ≤ 1 Billion €	5.360 €
> 1 Billion ≤ 3 Billion €	8.405 €
> 3 Billion ≤ 5 Billion €	10.500 €
> 5 Billion €	15.760 €
Associations	2.365 €

### Option 4\*: Full amfori Membership for associations

The following amfori membership fees apply to associations interested in engaging in amfori's full services, amfori BSCI, amfori BEPI and Advocacy and Trade Policy

\*Discounts apply if an association's member companies join amfori

Annual Turnover	Annual Fee
< 50.000 €	1.000 €
> 50.000 € ≤ 400.000 €	2.000 €
> 400.000 € ≤ 800.000 €	4.000 €
> 800.000 €	6.000 €

amfori membership is renewed on an annual basis in accordance with the amfori by-laws. amfori also offers, in exceptional circumstances, Affiliate Membership to companies with > €1 Billion and has a specific option for Associate Membership – information upon request.
